Meddling With The Scales

No matter how accurate and reliable a set of scales may be, if they are meddled with they may be made inaccurate and undependable. If we were weighing coal and the scales were out of balance a few pounds, it would not matter so much; but if we were weighing diamonds or gold, a very little variation would amount to a great deal. The more valuable that which we weigh, the more necessary it is that the scales be properly adjusted and accurate to a high degree. When it comes to a standard of weighing the human soul, that should be the most accurate of all standards. When it comes to judging ourselves, it is important that we have a right standard of judgment. That right standard God furnishes in His Word. It will weigh us accurately if we take it as it is: but if we misinterpret it or turn it out of its natural course and meaning, we may judge ourselves very wrongly by it. What we need to do is to be absolutely fair with ourselves. We must not allow ourselves to be prejudiced either in our favor or against ourselves. If our standard of judgment is so low that it permits us to be impure in heart and purposes and to do things that are wrong in the sight of God, that standard is evil for us, and we are not just to ourselves. If we have too high a standard and require more of ourselves than is just and right, again we do ourselves an injury.

We must learn to be fair to ourselves. We must require of ourselves all that we ought to require, but nothing more than that. In many lives the ideal is far too low, and consequently the life is too low. In other cases the ideal is too high and is entirely out of reach and can never be attained. We should have high ideals, but these ideals should be practicable and should not overlook the facts of human life. They should always be balanced by common sense. We should not live in a spiritual dreamland; for in practice we shall ever have to face the cold facts of life. These facts, not our dreams and imaginations, are what we must adjust ourselves to. If we have too high a standard, we shall always be coming short of it and condemning ourselves. A high ideal, if not too high, is a strong incentive to progress; but when it is made the standard by which we judge our present attainment, it tends to discourage us and becomes a real barrier to our progress. We can never attain to our ideals because they will ever grow as we grow, and they will continue to be in advance of us no matter how fast we grow. We must have a practicable, not an ideal, standard of judgment.

Making someone else our standard has its dangers. We cannot see another's inner life. We know nothing of his conflicts or his secret faults. We can see only the external manifestations. We do know our own inner life, but we can know theirs only as we judge it from outward appearance. God wants each of us to judge himself by His Word, not by any other standard, and He does not want us to judge ourselves by an ideal

People often make a serious mistake in comparing themselves with someone of a different temperament. It is very common to suppose that if a person makes many demonstrations in religion, he has a great deal of religion, and that if he is very quiet, he has no religion to speak of. I traveled to, a number of years in the gospel work with a minister whose temperament was decidedly emotional and who would sometimes become very demonstrative, leaping and shouting, and manifesting his feelings very plainly. I was of a rather unemotional temperament. I had powerful emotions sometimes, but it was not my disposition to give vent to them. People therefore judged that he had a much better experience than I had, and oftentimes I heard people remark that they wished that they had an experience like his. No one ever seemed to wish that about me. No one seemed to covet in the least an experience like mine. They all wanted one like his, because they thought he was so happy. We both had the same salvation and served the same God. The difference was a difference of temperament.

Salvation is not a thing of temperament, though manifestation is. To make our feelings and emotions a standard, is to make our temin the attitude of his heart towards God.

Preaching should never go beyond the bounds of common sense. We should never let our enthusiasm run away with our judgment. When feelings are preached, the strong-nerved preacher will preach a strong-nerved gospel, and the weak-nerved one will preach a weak-nerved gospel. The first will make no allowance for those who have weak nerves and who suffer the trials incident to their nervous condition; so he is likely to be the cause of bringing them into severe trials and conflicts. He has no idea of how things look and are to them. The other makes allowance for the infirmities of the weak and preaches his own experience. The strongnerved persons who hear him know that his experience is not like theirs, and they think that he is lowering the standard. The thing to do is to preach the Word. We may use our experiences to illustrate the things that we preach, but we ought to make it clear that experiences differ widely in many respects and that we should never judge one another by our experiences, nor should we expect our experiences to correspond fully with that of someone else.

The effect of too high a standard is always to discourage. We should have a proper standard, but not an ideal standard. We ought to

perament the standard. Those of other temperaments will differ from us. They can not and will not have the same experience so far as feelings and emotions are concerned. Great havoc has been caused by unwise preaching on these points. Preachers often relate their experiences, telling how happy they were and what wonderful emotions they had when they were converted. Others, hearing them, are led to suppose that if they too obtain salvation they will have these same emotions; so when they seek salvation, they seek these emotions. If they are of a different temperament, they do not experience them, and as a result they find it very difficult to suppose that they are saved at all. The preaching that emotion is ever a sign of salvation, in the sense that we can base our hope of God's favor and heaven upon it, is a serious error. Faith is the fundamental. Believing in God is what counts. Emotion is a superficial thing. It is not reliable evidence. and when people are taught to look upon their feelings as evidences, they do not get a settled experience, an experience that will take them through hard places when their feelings subside. A man's religion does not consist in the joy that he has nor in the amount of noise he makes, but require nothing of ourselves or others beyond a practical and common-sense Christian life. Sometimes the standard of a sanctified life is placed altogether too high, being out of reach. I once heard a sermon that left the impression on me that the preacher felt thus: "I am up here and a few others are up here, but most of you are down there, and you know that you are down there, and you are going to have a very hard time to get up here if you ever do succeed." The effect of that sermon was very discouraging, but it is far from the only one of the sort that has been preached. Many souls have been crushed by such preaching.

Many times I have heard the experience of sanctification described as such an ideal state that I knew the preacher himself nor anyone else had ever attained to such a state and never would in this life. Sanctification means the purification of our natures, but it does not mean the perfecting of our human faculties. It does not mean that we are automatically perfect in patience or kindness nor that we are in a state where our emotions will always be sweet and ideal. It does not mean that we shall never have a feeling of impatience or anger. Anger

comes from the violation of our sense of justice.

We ought to have the same standard of judgment for ourselves as we have for others. There are those who have a lower standard for themselves and excuse in themselves that which they could not and would not excuse in someone else. They are ready to condemn others for doing the very same things that they themselves do or things that involve the same principle. They find no excuse for others, but only condemnation, but they have a ready excuse for themselves whenever they are guilty of a like thing. Others go to the opposite extreme. They have a higher standard for themselves than they have for anyone else. They can excuse others for doing what they themselves would not feel clear in doing. They condemn themselves for things that they would not condemn others for. They can find excuses for others, but none for themselves. By adopting either of these courses, we do wrong to ourselves. God has the same standard for judging all people, and He desires that we have the same standard for judging ourselves. The standard we set for others is more likely to be correct than the one we set for ourselves. If the standard we set for ourselves is not a proper standard by which to judge others, it is not the proper one by which to judge ourselves. There is a true and just standard. Let us seek that and apply it to our own lives and the lives of others. The true standard is neither too high nor too low.

The standard by which God judges us is flexible, that is, He holds us responsible only for what we know; hence, the greater the light, the greater the responsibility of the person. Others will never be judged by our light nor we by theirs. It is only when persons have the same degree of light and when the circumstances are alike that the same standard is applicable to two or more individuals. But where light and circumstances are the same on any point, all must be judged by the same rule; and what is right for one is right for all, and what is wrong for one is wrong for all.

Overvaluing or depreciating ourselves and our work is another unwise thing. Whichever we do will turn out bad. It is not true humility to be always criticizing and undervaluing ourselves. If we do a thing, it is neither better nor worse than if someone else had done it, and we should not so regard it. Let us not have a double standard, one for ourselves and one for others. but let us have the same standard for all, and let that be a just and right standard, one that God's approval will rest upon. Then we may live satisfactory lives and have the blessings and approval of God upon us.

God's Scales Of Justice

Many people in the world today are very much interested in their physical weight. They watch it closely and live and eat in order to keep it correct. Not so many are interested in their spiritual weight, which is much more important. God weighs us by scales of justice. Our lives must weigh out even with the Word of God.

Job knew about God's scales of justice. He was greatly concerned about how he weighed. Job said, "Let me be weighed in an even balance, that God may know mine integrity." Job 31:6. He wanted the balance of justice to weigh him so God could see his integrity, honesty. purity, soundness, and sincerity. He did not want to come up short or long, but wanted to weigh out evenly.

Let us see how Job weighed out as recorded in the first and second chapters of Job. What did he say when he was told that the Sabeans had killed his servants and had taken his oxen and asses? How did he weigh out? Did he question God? How did he weigh out when he was told about the loss of his sheep, shepherds, camels and servants? This was a great loss and made him a poor man. Did he still love God? Praise God, we hear Job saying, "... The Lord gave, and the Lord hath taken away; blessed be the name of the Lord." Job 1:21. He loved God more than his possessions and that is how he weighed out in this trial.

Next came a servant telling Job that a wind had destroyed the house his children were in and they were all killed. Job rent his clothes and fell upon the ground worshiping God, and said, "The Lord gave, and the Lord hath taken away; blessed be the name of the Lord." Job weighed correctly in one of the supreme tests of

his life.

Job was weighed again in the balances of justice. He was smitten with sore boils from the sole of his feet to the crown of his head. His wife, who had also gone through the fire in the loss of all things, thought that this was too much. She was weighed and found wanting; she turned against God and questioned Job's integrity and sincerity. "Dost thou still retain thine integrity? curse God, and die," she declared. But Job weighed out well in this supreme test. His weight was pure gold. He said. "Thou speakest as one of the foolish women speaketh. What? shall we receive good at the hand of God, and shall we not receive evil?' In all this did not Job sin with his lips."

A neighbor's hogs got into the potato patch of a godly man. He drove them out and spoke kindly to his neighbor about it, but the neighbor did nothing to correct the situation. One day the man of God came home and the hogs were in

CHAPEL AND CAMPGROUND RELOCATION REPORT

We are glad to report that ground has been broken for construction of the Church of God chapel and dining hall on the new campgrounds at Guthrie, OK. The building site has been leveled, and a contract has been let for the foundation and floor. Construction should be

underway by the first of July.

The past several months have been spent taking a closer look at certain areas of the building design. Engineering assistance was enlisted to help in the design of the foundation, floor, structure, heat and air system. We have been working with several professional people in the building design and construction business which has taken considerable time. This has all been done in an effort to assure ourselves of a good sound structure, adequate to serve the needs of the saints and the work of the Lord here in the years to come. The trustees feel greatly the responsibility of seeing this project satisfactorily through to the end. The cooperative support of the saints is greatly coveted and California State at Pacoima, CA appreciated.

The financing of this project is being accomplished by the freewill offerings of God's people. This is not a local effort but a joint effort of all the saint congregations in Oklahoma and others in surrounding states. There has been concern expressed by some that this project will put the saints under a great burden of financial indebtedness. It is not the intention of the trustees to go out and borrow the money necessary for this project. By the same token. however, that should not lessen the financial responsibility we should each feel to support this part of the Lord's work. By not borrowing we will not incur the high interest payments that accompany such loans.

The current plans are to complete the total project in phases as the finances are made available. When adequate funds are on hand to complete the next phase, then that phase will be started. The first phase was the purchase of the property and the initial landscaping and leveling of the building site. That has been paid for. The second phase will consist of concrete work; the building footings, floor, and other concrete work in and about the building site. We should have adequate finances on hand to cover this phase. Phase three will consist of the purchase and erection of the main building structure and those materials necessary to seal the building up from the weather. This and each subsequent phase we will do as the Lord provides the finances. Hopefully, one phase can follow another without delay.

Please pray much for the brethren that have been given the responsibility for the oversight of this project. They are carrying a big load.

OK—Dear Print Shop family and readers: My testimony is overdue, but my burden and desire is to share a portion of God's wonderful works in my life. In my collection of notes which contain Scriptures that have gained the victories for me, I recently found my first Faith and Victory testimony. It was written as a newly saved 13-year-old, testifying to my first

healing. How I rejoiced! The Lord has been faithful to keep me in His care from age 13 to the grandmother I am today. I have never found anything dear enough to trade my salvation for. He is so precious to me!

My first near-brush with death was as a bride of one year, age 19. I experienced a painful, fearful, heart-searching 3 months of physical problems. The Lord gave me Hebrews 10:35, 36. He healed me!

In 1962 I suffered a heart attack. I begged the Lord to spare my life to cherish, train and care for my sweet 4-month-old baby girl, and 2 sons, ages 5 and 7. It was a hard year of recuperation, but the Lord healed me.

In 1964-65, I suffered a total nervous breakdown with severe anemia. I now had 2 baby girls and 2 boys. The saints and relatives again supported me with their love and prayers. The Lord was faithful and He gave me Isaiah 40: 28-31. I was able to gain strength to care for my precious family once more.

In 1961-69, I suffered another severe physical affliction of which the Lord healed me.

It was in 1969-73 that I suffered severe attacks with gallstones, lasting days at times. I doubled in pain for hours, and would be sore for 2 to 3 days. Caring for my growing family was difficult. An examination revealed my condition critical and in the last stages. I searched my heart, presenting to God my ever-present burden for my children's souls and their need of a mother's care and my faith soared. The Lord healed me! In 2 or 3 months I was able to eat a normal meal, and slowly I regained my strength.

In 1977, I developed a severe kidney infection and suffered severe pain. I felt so weary and longed to see Jesus. The saints came in singing hymns and praying the prayer of faith. The Lord healed me!

Prior to 1983, a small spot on my lower right leg began to spread, growing into a molelike area. A soreness began to develop in it. In the fall of 1986, the need of a dermatologist's examination was required. The verdict was malignant melanoma. This is the most dreaded of 3 skin cancer types. Surgery was advised as a must. In medical news reports it states that early detection of malignant melanoma with surgery can add 10 years of life. In more advanced cases, only 5 years is added by surgery. Melanoma spreads quickly throughout the body in the advanced stage and is fatal. I told the doctor of God's great healings in my past, and that my trust was still in Him. She was troubled and gave me 6 months to live at the most without surgery. In my work, I see the results of surgery, radiation, chemotherapy, etc. What I see everyday encourages me to look to the Lord.

The Word of God has always been so real

since the Lord saved me at age 13 in the Jefferson Oregon Camp Meeting. As I look on the past I value Sis. Mattie Wilson who spent her life working with young people. She taught me the value of faith. My dear mother, Mable Melot, set an example for me in teaching her family about God. My dear mother-in-law, Lillian Meek, helped me win many battles and to gain victories. I obeyed James 5:13-15 one more time to gain another victory. This was in the fall of 1986 and yet my leg grew worse. The need to work full time on my feet all day, along with home duties, took its toll on my nervous system. It required super strength from the Lord to shoulder my heavy responsibilities, to keep going and not give up.

I reminded the Lord often of His promises. The saints again kept me in their prayers and showed love and concern; as well as friends, relatives and neighbors. The Lord held me close.

In September 1988, I removed a bandage for the last time. Praise the Lord! A very small spot remained my Peniel. "I have seen God." (Genesis 32:30). All praise and honor is due our Saviour. Oh, how dear the saints have been. I am glad they are my people! It means so much to support the afflicted children of God with love, prayers, letters and phone calls, and I desire to do my part. Rejoice with me, that we may all reap His rich benefits together.

These are not all of God's healing touches to me, but I felt impressed to share these few. "What a mighty God we serve!" "I've started for heaven, my heart filled with song." "Yes, Jesus took my burden and left me with a song." "If I had ten thousand lives in which to praise Him, I could not enough my blessed Lord adore!" May the Lord reward each of you richly. Let us endeavor to the end, for heaven will be worth more than every tear, pain, or battle.

Dear saints: The following is our travel experience in Honduras, Central America. On Wednesday, May 17, 1989, a group consisting of Bro. Louis Kimble, Bro. Keith Fuller, and his two daughters, Tauna and Krista, and Sis. Dianne Fuller left for Honduras. Arriving on the same day at Roatan Island, Honduras, we were

met by the saints and proceeded to our home base in Politele. This is the home of Bro. and Sis. Sanders.

The following day we set up the gospel tent in the town of Punta Gordo. The site was on the beach right on the edge of the sea. 

Question: What is the meaning of the term "peculiar people" in I Peter 2:9? Does it mean strange or odd?

Answer: Not at all. This text is speaking of what God's people are to Him, and God does not make a people who would be odd or strange unto Himself. On the contrary, they are His jewels (Malachi 3:17) and special treasure (Deuteronomy 7:6). They are the chosen of God, elect and precious. This is what God's people are to Him. Oh, the blessedness of being chosen by God to be one of His special people.

Of course, this does not describe what the saints are to the world nor the way the world looks at us. We are to them a strange spectacle with our conduct of self-denial, loving our enemies, doing good to them that hate us, praying for those who persecute and revile us, turning the other cheek, going the second mile, giving the cloak with coat, etc., as compared with the self-centeredness, every fellow for himself and the devil for us all, attitudes. But, as before mentioned, this text is referring to what the people of God are to Him and not to the world.

Now we will notice some texts which contain the term "peculiar," or its equivalent, and see what their use is in the Scriptures. "Now therefore, if ye will obey my voice indeed, and keep my covenant, then ye shall be a peculiar treasure unto me above all people: for all the earth is mine: And ye shall be unto me a kingdom of priests and an holy nation. . . ." Exodus 19:5. 6. Note the use of the term here, a peculiar treasure unto me above all people. This would clearly refer to a separated group of people from among all the other people of the earth. In Deuteronomy 7:1-6 we read how the Israelites were to deal with the people of the land when they entered Canaan. They were to utterly destroy all their places and facilities for sacrifice and worship. Verse 6 plainly states the reason for this stern indictment. It says, "For thou art an holy people unto the Lord thy God: The Lord thy God hath chosen thee to be a special people unto himself, above all people that are upon the face of the earth." This text uses the term "special people" instead of "peculiar treasure" as in Exodus 19:5, 6. These are alternate terms

used in the same way and clearly mean the same things. Read also Deuteronomy 14:2; 26:16-19; 28:9; 29:13 and I Kings 8:53.

In all the above texts the terms of peculiar, holy, special and separate, have the same meaning and describe the same relationship between God and His people. This is just about, if not altogether, the total meaning and scriptural use of the term "peculiar people" in the Bible.

Our text (I Peter 2:9) and Titus 2:14 may be the only places in the New Testament where the term "peculiar people" is used, and clearly it is used in the same way and means the same thing as its use in the Old Testament in regard to ancient Israel, the chosen people of God in that time. Titus 2:14 says this, "Who gave himself for us, that he might redeem us from all iniquity, and purify unto himself a peculiar people, zealous of good works." It is clear in this verse that the ultimate objective of Christ's sacrifice at Calvary was to redeem and save us from all sin and unrighteousness and purify unto Himself a peculiar or separated people. In II Corinthians 6:14-18 we read, "Be ye not unequally yoked together with unbelievers: for what fellowship hath righteousness with unrighteousness? and what communion hath light with darkness: And what concord hath Christ with Belial? or what part hath he that believeth with an infidel? And what agreement hath the temple of God with idols? for ye are the temple of the living God; as God hath said, I will dwell in them and walk in them; and I will be their God, and they shall be my people. Wherefore come out from among them, and be ye separate, saith the Lord, and touch not the unclean thing; and I will receive you, And will be a Father unto you, and ye shall be my sons and daughters, saith the Lord Almighty." Here is clearly taught the doctrine of total separateness and the reason for it: because the opposites mentioned here can by no means blend. Therefore, since He has provided the sacrifice in His Son, Jesus to fully cleanse us from sin and purge us from every impure and unrighteous thing in His blood. He now requires us to be separated from all these things unto Him. He now requires us to touch none of the unclean things from which He has purged us in the blood of His Son, and maintain a holy and righteous life separated unto Him.

"Why were the saints, saints? Because they were cheerful when it was difficult to be cheerful, patient when it was difficult to be patient; and because they pushed on when they wanted to stand still, and kept silent when they wanted to talk, and were agreeable when they wanted to be disagreeable. That is all. It was quite simple and always will be."

Good Fathers

That a good mother is a gift from God is a truth we often hear attested, and it can be said with equal truthfulness that good fathers are God-given. It is true that the mother has the greater care of the child, especially in its infancy, but it is a mistake to thrust upon her all the responsibility of its training through childhood and youth. The mother has her part, but there is a part that belongs to the father, and if he fails, the child is robbed of part of its rights.

It is the father's part to provide for the temporal needs of his child, and to this responsibility every right-thinking man responds; but too often when the temporal needs are supplied, the father thinks he has done his part.

A good father keeps acquainted with his children. And this is no small undertaking if there are several little people in the home all rapidly growing and developing. He will have to be with them more than at mealtime and on Sunday afternoons to keep up a continuous acquaintance. And he will have to unbend himself and meet the children on their own territory and be a child with them. It is a good cordial for tired nerves just to have a merry romp with the children; and Father seems so close after such a romp. It is through play that children meet and know other children, and fathers also can best know their children if they meet them frequently this way. If the father keeps his eyes open, he will be able to detect the very tendencies that, unrestrained, will injure his children in coming years. And he can make the child see the fault much easier because he has seen it from the child's point of vantage. Good fathers, then, are good comrades with their children.

A good father respects the feelings of his children. He will not single out one little offender and make him and the rest of the family miserable during a whole meal with his scathing

reproofs and jeering remarks. He will not growl or roar at them till their little nerves tremble. "Like as a father pitieth his children" is an application which his children can understand. Even if he must correct severely, underneath his severity will be pity and compassion.

Good fathers are interested in the things that interest their children. Many a child has stood anxiously by with some work of his own hands desiring to show it to his father, but fearful lest he be sent away with an admonition not to bother, or that the father would look it over with a hasty glance and a "h'm" and then go on with his reading. Children want to please their fathers, want their association and appreciation, and will seek after them; but only a few fathers are truly responsive.

Our heavenly Father remembers that we are dust; and a good earthly father remembers that his children are weak and inexperienced, that their characters are yet unformed, that their judgment is yet unstable, and for these reasons he does not expect them to be able to act and think like men and women. He can be considerate with them when they are at fault, can feel compassion when they are in trouble, and forgive them when they repent. He cares more for their welfare and happiness than for his own, and not only toils day after day for them, but is able to meet them with a smile when the day is done.

This man weighed out right; he trusted God's wisdom in all that touched his life.

We are on one side of God's scales of justice and God's Word is on the other side. We should check daily to see that our lives measure up to the Word. Those who check their weight daily can correct any difference easily before it gets too large. It is important that we live a life dedicated to God's cause and reject any selfish desires or ways, thus proving that we love Him with all our hearts. We are only in the world a short time and we shall be weighed in the judgment day for the last time. On that day it will be a final weighing. There will not be any opportunity to correct any difference. Now is the time to watch our weight.

One day Jesus weighed a man who came running, then knelt before Him and asked, "What shall I do that I may inherit eternal life?" Jesus said to him, "Thou knowest the commandments, Do not commit adultery, Do not kill. Do not steal. Do not bear false witness, Defraud not, Honour thy father and mother." (Mark 10:17-22). He was being weighed by the Word of God. How did he weigh out thus far? The man felt good because he had kept all of these commandments from his youth. Jesus looked on him and loved him. God and His people appreciate those who live clean, upright lives, but it takes more than that to balance out correctly on God's scales. We must be "born again," and also surrender ourselves, possessions and our all into God's hands. We just become stewards of our lives, possessions and time. We do not belong to ourselves because we have been bought with a price. We belong to God. Paul said, "I am crucified with Christ: nevertheless I live; yet not I, but Christ liveth in me: and the life which I now live in the flesh I live by the faith of the Son of God, who loved me, and gave himself for me." Galatians 2:20.

Jesus continued to weigh the man. He told him to sell all that he had and give to the poor, take up his cross and follow Him. The poor rich man was grieved. He was weighed and found wanting that time. He had opportunity to change his weight, but he refused and went away sorrowful. He lacked enough weight to balance out correctly with God's Word. Dear ones, it would have been better for him to have weighed out like Job. When God saw that Job weighed out correctly, He blessed him. He gave him more sons and daughters and twice as much in possessions as he had lost. His latter end was better than the beginning. (Job 42).

God has prepared a beautiful home in heaven for those who are faithful and endure to the end. This world is not our home. We are on our way to those treasures in heaven. We want to weigh correctly on God's scales of justice in this life so when we get on them for the last time in the judgment day we shall balance out correctly and be ready to enter God's heaven.
